All required documents pertaining to the type of permit being applied for must be provided to the Planning Commission at the time the permit is requested. Failure to do so will result in denial of the permit.

II. Type of Permit

- 1. New construction. Inspection required before Certificate of Occupancy permit will be issued.
- 2. Addition - If residential, enter number of new housing units added, if any, in Part B
- 3. Alteration/Remodeling
- 4. Demolition - If multifamily residential enter number of units in building in Part B
- 5. Moving/Relocating
- 6. Sidewalks

III. Construction Site Document Requirements

- 1. Proof that locates have been requested from 811. May be requested online at <http://indiana811.org/> or by phone at 811 or 800-382-5544.
- 2. Survey or drawing of proposed construction location. Site dimensions should include: building dimensions, setback dimensions from property lines and/or easements, and utility locations. GIS drawings may be obtained online at the following address: <https://beaconbeta.schneidercorp.com/>
- 3. Fences must be installed 12" (1 foot) off the property line. No fence exceeding three (3) feet shall be located upon a lot within 30 feet of a street intersection and at no time shall a fence be higher than eight (8) feet.
- 4. See ordinance 2015-21 for sign regulations and permit fees.
- 5. Demolition - If asbestos is suspected to be present, testing must be preformed and results presented with permit application.
